<b>CSCM41 Introduction to Programming in Java</b>	
<b>Credits: 15 Session: 2023/24 September-January</b>	
<b>Pre-requisite Modules:</b>	
<b>Co-requisite Modules:</b>	
<b>Lecturer(s):</b> Dr T Doan	
<b>Format:</b> 10 hours lecture, 20 hours lectures in lab environment, 10 hours lab.	
<b>Delivery Method:</b> On-campus lectures and lab sessions.	
<b>Module Aims:</b> This intensive course provides a solid introduction to the Java programming language and development process.	
<b>Module Content:</b> Introduction to Programming. Introduction to Java. Basic structures of programming. Functions (static methods). The Object-Oriented paradigm: objects, classes and methods. Various I/O methods, and input/output via command-line. Basic correctness for programming (precision, finding and correcting errors). Aspects of exception handling and defensive programming.	
<b>Intended Learning Outcomes:</b> Students will be able to: Use variables, expressions and control structures, together with elementary input/output facilities. Understand and properly use functions, static as well as non-static ones (methods). Understand the foundations of classes, with methods and constructors, complete the foundations of basic programming. Understand the fundamental concepts of correct and precise programming. Design and implement working Java programs in a modular maintainable style to the standard required in a Masters degree. Read code written by others, and to identify errors and bugs and to correct them.	
<b>Assessment:</b>	Examination 1 (50%) Coursework 1 (20%) Coursework 2 (20%) Laboratory work (10%)
<b>Resit Assessment:</b>	Examination (Resit instrument) (100%)
<b>Assessment Description:</b> Standard Computer Science format unseen examination, duration 2hrs. Coursework 1 and 2 - practical assignments.	
<b>Moderation approach to main assessment:</b> Moderation by sampling of the cohort	
<b>Assessment Feedback:</b> Outline solutions provided along with group and individual analytical feedback for courseworks. Examination feedback summarising strengths and weaknesses of the class. Individual feedback on submissions from lecturer and/or demonstrators in laboratory sessions.

## MA-D01 Actuarial Science Masters Dissertation

**Credits: 60 Session: 2023/24 September-June**

**Pre-requisite Modules:**

**Co-requisite Modules:**

**Lecturer(s):** Prof C Yuan

**Format:** 12 - mixture of introductory lectures and individual supervisions.

**Delivery Method:** Individual project supervision

**Module Aims:** A research project selected from an area of Actuarial Science. It will enable the students to develop an enquiring, analytical critical and creative approach to problem identification and solution. The project will typically focus on a subject area related to one of the taught modules in the MSc scheme.

**Module Content:** The student will study an area of Actuarial Science related to the content of the taught part of the MSc scheme, drawing together material from different published sources, and their own investigations, to produce a substantial written report on the topic.

**Intended Learning Outcomes:** At the end of this module, the student should be able to:  
plan and undertake a significant project with a high degree of independence,  
synthesize information and ideas;  
independently evaluate alternative approaches to a given problem;  
accurately report on and evaluate their own work, and work of others;  
perform and present research in an ethical manner;  
communicate complex mathematical ideas and concepts.

**Assessment:** Dissertation (100%)

**Assessment Description:** Written dissertation, including presentation, subject to the regulations for an MSc dissertation.

**Moderation approach to main assessment:** Universal Non-Blind Double Marking of the whole cohort

**Assessment Feedback:** Students will receive ongoing feedback during the meetings with their supervisor. The official result of the MSc dissertation will be communicated to the student by the University. The student can receive individual feedback on their dissertation from their supervisor, informed by the views of both markers.

**Failure Redemption:** Resubmission of the dissertation, in accordance with the University regulations.

**Additional Notes:** Dissertation for the MSc Actuarial Science programme. Only available to students on the MSc Actuarial Science programme.

Each student will be assigned a member of staff as a supervisor who will help to choose the topic to be studied, and guide the student. Each student will be required to produce a word-processed thesis of 15,000-20,000 words, based on topics covered in the taught part of the MSc scheme, and on published research in the field.

<b>MA-M08 Machine Learning</b>	
<b>Credits: 15 Session: 2023/24 January-June</b>	
<b>Pre-requisite Modules:</b>	
<b>Co-requisite Modules:</b>	
<b>Lecturer(s):</b> Prof B Lucini	
<b>Format:</b> 44 hours consisting of a mixture of lectures and computer lab classes	
<b>Delivery Method:</b> Lectures supported by regular computer lab sessions.	
<b>Module Aims:</b> The module introduces basic concepts of machine learning and some of its popular methods in a practical manner from a mathematical perspective.	
<b>Module Content:</b> 1. Introduction to Machine Learning – Machine learning: methods and terminology; classification and regression problems; binary classification; categorical and continuous variables; the general process of a machine learning analysis: data collection, feature design, choice of model, model training, model validation; types of learning: supervised, unsupervised, reinforcement. 2. Optimisation for Machine Learning – Cost function and its optimisation; zeroth-order optimisation methods: grid search, random and coordinate search; the curse of dimensionality; first-order methods: gradient descent, batch gradient descent, stochastic gradient descent; ADAM acceleration; hyperparameters in Machine Learning. 3. Linear regression – Linear regression as a machine learning problem; the mean square cost function; the absolute deviation cost function. 4. Classification – Two-class classification; classification methods in machine learning: logistic regression, perceptron, and support vector machine; introduction to multi-class classification and the k-Nearest-Neighbour (kNN) classifier. 5. Robustness metrics – Model error on new data; training error and generalisation gap; bias, variance and their trade-off; k-fold cross-validation; the VC dimension; additional tools for evaluating the performance of binary classifiers: classification errors, confusion matrix, precision, recall, F1-score, ROC curve and Area Under the Curve (AUC). 6. Unsupervised linear learning – Linear autoencoders; Principal Component Analysis; k-Means Clustering. 7. Principles of non-linear learning – Non-linear regression; non-linear classification. 8. Regularisation – Ridge regression (L2 regularisation); lasso regression (L1 regularisation). 9. Tree-based learners – Introductions to trees; from stumps to regression trees; classification trees; random forests. 10. Introduction to deep learning – From the perceptron to fully connected neural networks (FCNN); FCNN architectures; activation functions; the computation graph; automatic differentiation; backward propagation.	
<b>Intended Learning Outcomes:</b> At the end of this module, students should be able to:	
<ol style="list-style-type: none"> <li>1) Critically analyse the feasibility of approaches to machine learning .</li> <li>2) Demonstrate a comprehensive understanding of the fundamental mathematical ideas behind the standard approaches to machine learning.</li> <li>3) Apply a broad range of machine learning techniques to data sets using appropriate programming languages.</li> <li>4) Analyse the strengths and weaknesses of a wide range of different approaches to machine learning.</li> <li>5) Determine appropriate methods to apply to given data sets.</li> </ol>

<b>Format:</b> 44	
<b>Delivery Method:</b> Primarily on campus	
<b>Module Aims:</b> The techniques developed take the cost of computation into account, an important consideration even with immense computational capability available on modern laptop computers.	
<b>Module Content:</b> - systems of linear equations; Gaussian elimination, pivoting strategies, PLU decompositions, residuals and error correction, iterative methods.	
- eigenvalues and eigenvectors; Gerschgorin theorems, power methods (PM/IPM/SIPM), Rayleigh quotient method, Householder transformation, Hessenberg form, QR decomposition, QR iteration.	
- numerical integration; Adams-Bashforth methods, Monte-Carlo methods

1) Demonstrate extensive familiarity with techniques appropriate to the efficient solution of large linear systems

<b>Module Aims:</b> This module covers the actuarial pricing structure of life assurance and annuity contracts, including a variety of payment and premium structures as well as two-life policies. It covers material related to sections 4, 5 and 6 of the Institute and Faculty of Actuaries CM1 syllabus.	
<b>Module Content:</b> i) Assurance and annuity contracts  ii) Payments – means and variances  iii) Two life policies  iv) Multiple transitions  v) Multiple decrements  vi) Future loss  vii) Gross premiums and reserves  viii) Death strains  ix) Future cashflows	
<b>Intended Learning Outcomes:</b> At the end of this module, a student should be able to: 1) critically evaluate a range of assurance and annuity contracts, 2) demonstrate advanced skills with payments under various assurance and annuity contracts, 3) calculate using advanced techniques cashflows contingent upon the nature of transitions, 4) demonstrate advanced skills calculating gross premiums and reserves for assurance and annuity contracts and projecting future cashflows for a variety of typical contracts.	
<b>Assessment:</b>	Examination (80%) Coursework 1 (6%) Coursework 2 (7%) Coursework 3 (7%)
<b>Resit Assessment:</b>	Examination (Resit instrument) (100%)
<b>Assessment Description:</b> Examination: A closed book examination to take place at the end of the module. Courseworks 1-3: This coursework will develop skills in problem solving, applying techniques to real world problems and understanding the use of computers to investigate problems.	
<b>Moderation approach to main assessment:</b> Moderation of the entire cohort as Check or Audit

<b>MA-M49 Probability and Statistics for Finance</b>	
<b>Credits: 15 Session: 2023/24 September-January</b>	
<b>Pre-requisite Modules:</b>	
<b>Co-requisite Modules:</b>	
<b>Lecturer(s):</b> Dr Z Sobol	
<b>Format:</b> 20 hours: 10 hours of practical workshops and 10 hours of PC labs.	
<b>Delivery Method:</b> The module will be delivered using a flipped approach with material provided via Canvas for students to prepare for regular workshops and PC labs.	
<b>Module Aims:</b> This module provides an applied introduction to the theories of probability and statistics with a particular focus on applications from finance and insurance. It takes a practical approach and focuses on the use of the programming language R in statistical analysis.	
It covers material related to the syllabus for CS1 from the Institute and Faculty of Actuaries.	
<b>Module Content:</b> 1) Probability theory: basic probability spaces, probability measures, random variables, distributions, moment & cumulant generating functions, expectations, independence, joint distributions, conditional distributions, conditional expectations, Bayes formula, central limit theorem. 2) Statistical Analysis: Sampling and populations, parameter estimation, maximum likelihood estimators, confidence intervals, hypothesis testing. 3) Regression: Linear regression, generalised linear models. 4) Bayesian statistics: Prior and posterior distributions, Bayesian estimators.	
The programming language R will be used throughout the module.	
<b>Intended Learning Outcomes:</b> After completion of the module, the student should be able to; 1) demonstrate a systematic understanding of probability theory, 2) critically evaluate the application of a broad selection of probability distributions in financial modelling, 3) demonstrate advanced skills in testing statistical hypotheses in both parametric and non-parametric settings, 4) demonstrate a systematic understanding of regression techniques, 5) analyse and investigate large, incomplete, and contradictory data sets using specialist techniques, 6) autonomously analyse statistical data using statistical software, 7) analyse statistical output and communicate outcomes in an appropriate manner.	
<b>Assessment:</b>	Examination (70%) Assignment 1 (20%) Assignment 2 (10%)
<b>Resit Assessment:</b>	Examination (Resit instrument) (100%)
<b>Assessment Description:</b> Exam: a written, closed-book examination at the end of the module to assess students understanding of theoretical of probability and statistics, their ability to model and analyse real world financial problems, their ability to interpret statistical analyses and their understanding of R use. Assignment 1: is composed of several coursework assignments spread through the term to build skills in problem solving and statistical analysis. Assignment 2: is a computing test held under controlled conditions at the end of the module to assess their skills in programming in R and interpreting R output for real world problems.	
<b>Moderation approach to main assessment:</b> Moderation of the entire cohort as Check or Audit	
<b>Assessment Feedback:</b> For the homework assignments and computing test, students will receive feedback in the form of marks, model solutions, overall feedback on the cohort performance, and some individual comments on their work.	
For the exam, students will receive feedback in the form of marks and overall feedback on the cohort performance.	
Further, individualised feedback, can be provided upon request.

<b>MA-M58 Financial Mathematics in Discrete Time</b>	
<b>Credits: 15 Session: 2023/24 September-January</b>	
<b>Pre-requisite Modules:</b>

<b>Lecturer(s):</b> Dr I Rodionova	
<b>Format:</b> There be weekly delivery, with each week have 3 lectures and 1 examples class.
